Promoting Peace and Health in the Middle East: APHA Considers Policy on Palestian Health

PHA will vote on an important policy resolution, C7: Improving Health in Occupied Palestinian Territory at the upcoming annual meeting. C7 documents the ways that Palestinian population health is undermined by the military and administrative conditions created by the Israeli occupation of the West Bank, Gaza, and East Jerusalem. C7 has five specific calls for public action: (1) supporting international diplomatic work to end the Israeli-Palestinian conflict; (2) strengthening the physical and mental health systems in the occupied territories; (3) promoting joint health projects between Palestinians and Israelis; (4) investing in maternal and child health in the occupied territory; and (5) expanding social choice investment funds which screen out companies involved in maintaining the occupation. New Study Finds Half a Million Iragis Died in War

Research published this month by Amy Hagopian et al found that approximately a half million deaths in Iraq could be attributable to the war. The study concluded, "beyond expected rates, most mortality increases in Iraq can be attributed to direct violence, but about a third are attributable to indirect causes (such as from failures of health, sanitation, transportation, communication, and other systems). Dr. Hagopian will be presenting the study findings at session 4243.0 at 12:30 - 2:00 BCEC, 052A.
