Remembering 9/11

APHA Past-Presidents Barry Levy and Victor W. Sidel were among the list of prestigious contributors to the Lancet's September 1, 2011 issue which presented reflections on the events of 9/11, including research, review, and opinion pieces on the short-term and long-term physical, mental, and public health consequences of the attacks. The research papers report US domestic health effects and also some of the international consequences. In their article, Adverse health consequences of US Government responses to the 2001 terrorist attacks, Drs. Levy and Sidel assess such adverse health impacts as the wars in Afghanistan and Iraq, violations of human rights in these countries, and the diversion of human and financial resources.

A survey of estimates by the *New York Times*, found the cost of the response to 9/11 to be \$3.3 trillion, or about \$6.6 million for every dollar Al Qaeda spent planning and executing the attacks. The *Times* article notes that while not all of the costs have been borne by the government -- and some are still to come -- this total equals one-fifth of the current national debt. See: Cox A.
